INCREASE IN CAPITAL AND CHANGE IN DIRECTORS' AND

SUBSTANTIAL SHAREHOLDERS' INTERESTS

Mermaid Maritime Public Company Limited (the "Company") wishes to announce that the issued share capital of the Company has now been increased from 523,205,340 (Five Hundred and Twenty Three Million Two Hundred and Five Thousand Three Hundred and Forty) ordinary shares to 541,205,340 (Five Hundred and Forty One Million Two Hundred and Five Thousand Three Hundred and Forty) ordinary shares all have a par value of THB 1 (One) each. This increase in issued share capital was registered with the Ministry of Commerce in Thailand on 26 October 2007.

The increase in issued share capital was made pursuant to the exercise of the Overallotment Option on 24 October 2007 by Macquarie Securities (Singapore) Pte Limited in connection with the initial public offering of ordinary shares in the Company for the purposes of covering the 18,000,000 (Eighteen Million) ordinary shares which had been over allocated.

The increase in issued share capital has resulted in a change to the interest held by directors and substantial shareholders of the Company due to the resulting dilution. Such change is a change in the percentage of interest against issued share capital. There is no change to the number of shares held by such persons.
