### HOW TO GET TO SUNTEC SINGAPORE

#### By Public Transport

The nearest MRT Stations are Esplanade Station and Promenade Station via the Circle Line which will bring you directly to Suntec City Mall. Alternatively, take the MRT to City Hall Station, followed by a five to ten minutes walk via an underpass to Suntec City Mall.

Bus services to Suntec Singapore: 36, 70M, 111, 133, 133A, 162M, 518, 518A, 700A, 857, NRI, 97, 97A, 70A, 106, 502, 502A, 502B, 518, 551, 578, 581, 577, 580, 575, 576, 579. Alight right in front of the Convention Centre.

#### By Road/Car

Access Routes to Suntec City include Raffles Boulevard (from Bras Basah Road), Temasek Avenue, Rochor Road exit from East Coast Expressway and Nicoll Highway.

Suntec Singapore is accessible via 2 major expressways: East Coast Expressway (ECP) and Central Expressway (CTE). There are prominent signages directing the way to Suntec Singapore, which is located south of the Office Towers. There are a total of 3,100 parking lots available in the basement of Suntec City, and many more are available in the vicinity.
