ANNOUNCEMENT OF USE OF PROCEEDS FROM THE RIGHTS ISSUE

1. INTRODUCTION

1.1 Mermaid Maritime Public Company Limited (the "Company") refers to the Circular released on 8 April 2025 (the "Circular") and the previous announcements made on 28 February 2025, 1 April 2025, 6 June 2025, 9 June 2025, 20 June 2025, 3 July 2025 and, 8 July 2025 relating to, amongst others, the Rights Issue. Unless otherwise defined herein, all capitalised terms used herein shall bear the same meanings ascribed to them in the instructions booklet dated 20 June 2025 ("Instructions Booklet"), and the Company's announcement dated 14 August 2025 relating to the Use of Proceeds ("Previous Announcement").

2. USE OF PROCEEDS FROM THE RIGHTS ISSUE

- 2.1 After deducting the costs and expenses of approximately \$\\$0.244 million incurred in connection with the Rights Issue, the Company has raised Net Proceeds of approximately \$\\$56.091 million from the Rights Issue.
- 2.2 Further to the Previous Announcement dated 14 August 2025, the Board wishes to provide an update on the utilisation of the Net Proceeds as follows:
