BFTZ is strategically located on Bangna-Trad Road km.23, and easily accessed from both Bangna-Trad Km.23 Road and Bangna-Trad Km. 19. It is also near strategic ports, airports, and well-connected to major roads with transportation linkages between Bangkok and other provinces in all regions. As being a leading provider of high-standard warehouses and factories for rent with one-stop service solutions, BFTZ is announced in the government gazette as an Industrial Zone operated in both Free Zone and General Zone.







Q3/2021 OVERVIEW

The operating results for the 3rd guarter ended September 30th, 2021 (Q3/2021). PROSPECT REIT had total income of 114.11 million Baht, which increased 3.00% from the last guarter. 


